### **Office Report - Graham**

#### **Finance**

As of February 28, 2017 the PDGA had a net financial position of \$1,484,414 as compared to \$1,299,013 at the same time in 2016, representing an increase of \$185,401.

Since 2016 numbers included a large number of Vibram Birdie Bashes which will not be sanctioned in 2017, the XC numbers have been normalized to show a truer picture of growth.

- So far in 2017 we have 1,789 events in the database compared to 1,634 at this time last year which is an increase of 9.5%. The US is at 14.3%, Canada is at 2.4%, and International events are off the pace from last year at -9.3%. The change in sanctioning for those non-US events from February to April appears to be sluggish compared to the same period in 2016. However, none of the red numbers are alarming at this time, and many are relatively minor differences for this early in the year.
- 2016 Stats at this time of year did include a a large amount of Vibram Birdie Bashes which are not being sanctioned this year. These XC events have been removed to provide a more accurate picture of 2017 growth.
- The first Player Ratings Update for 2017 events took place on March 28<sup>th</sup>.
- April 4th was the deadline for the second update for 2017 events and we gave completed processing of those events and sent them to the ratings team. The publication date was originally scheduled for Tuesday, April 25<sup>th</sup> but since I will not be able to return from the Amateur Championships at Bowling Green in time to complete the processing, it will be delayed a day to Wednesday, April 26<sup>th</sup>.

# Committee Reports

Senior – Dave West reported on the progress of the committee on their planned fun senior event on July 9-11 at Kent State University in Ohio.

PDGA Europe – Hans Nagtegaal reported on discussions amongst the committee related to the upcoming elections for PDGA Europe board members.

### **New Business:**

### PDGA Smoking Policy

The Board discussed whether the PDGA smoking policy should be extended to additional tiered events as it is currently only in effect at PDGA Major events. Brian Graham explained that the policy was passed in 2011 and it was the intention of the board at that time that the topic be revisited and future consideration be given to enacting the policy at other tiered events. Graham suggested stair step the policy if they wanted to enact it at additional events and that they start with the National Tour events first since we have staff present at those events and they receive a higher degree of media coverage and spectatorship. Hans Nagtegaal expressed support for enacting the policy at all PDGA sanctioned events, citing our professional sports image. Kevin McCoy stated that he preferred to let the players police themselves and that we not pass a PDGA rule but allow local laws and park rules to determine if smoking is prohibited on the course. Discussion ensued with board members discussing the challenges of a blanket policy at all sanctioned events versus just the higher tiered events.

### **MOTION** (Menickelli/West)

To extend the current PDGA smoking policy to include PDGA National Tour Events beginning in 2018. Yes: West, Menickelli, Duffy, Sinclair

# PDGA Sponsorship Policy

The PDGA Sponsorship Policy was discussed and Shawn Sinclair questioned whether the policy should be reviewed to consider prohibiting the acceptance of sponsorships from companies such as legal marijuana dispensaries, that might be harmful to the image of the association and sport. Brian Graham stated that the PDGA had a pretty good sponsorship policy in place which allowed flexibility so that the tournament directors could consult with the office if they needed

assistance in making a tough decision. Graham went on to say that he was not aware of any issues in the past that the current policy did not adequately cover. Discussion ensued and the consensus of the board was that our current policy was sufficient and that changes were not necessary at this time

### Fall Summit

The board discussed the 2017 Fall Summit in hopes of setting a date and location. Brian Graham stated that he had uploaded the IDGC events calendar to the Yahoo Group for board review, and recommended that it be held in October in conjunction with the Disc Golf Hall of Fame Classic, which is the final event in the 2017 NT series and the planned location of the Hall of Fame inductions this year. Discussion ensued about other options and it was ultimately agreed upon that the Fall Summit would take place on Monday and Tuesday, Oct. 16-17, following the HOF Classic at the PDGA International Disc Golf Center.

*NASC Symposium Report – Graham* Brian Graham submitted the following report:

NASC Symposium Report March 27-30, 2017 Sacramento, CA

Hosted by: National Association of Sports Commissions

Brian Graham attended the NASC Symposium in Sacramento, CA on March 27-30, 2017 in his capacity as interim Executive Director of the PDGA, and a member of the NASC Events Rights Holders Committee. The PDGA once again had a full schedule and Graham conducted the maximum of 54 one-onone appointments, and 12 event overview appointments, meeting with a total of 102 destinations and sports service companies to discuss PDGA events. Included in those appointment sessions were meetings with the sports commission and/or Convention and Visitors Bureau representatives for a number of cities that will soon be hosing PDGA Major events including Grand Rapids, Quad Cities, and Charlotte, as well as by many who are interested in our bid process.

The PDGA remains one of the most highly requested sports organizations at these shows by sports commissions and is highly respected amongst other sports governing bodies who often seek our advice on how they can emulate what we have achieved. The PDGA donated a disc golf starter set (bag, discs, mini, towel, DiscGolfer magazine, stickers, hat, brochures) to the NASC Sports Legacy Auction and the winning bidder turned out to be Talty O'Connor, the founder and owner of another large national sports conference (SPORTS Relationship Conference) that we attend each year.

Brian will be bringing Joe Chargualaf up to speed on these conferences as part of training and transition of ED duties and recommends that Joe attend them in the future. Brian will be attending these sports conferences moving forward as he introduces the National Barrel Horse Association to them, and he would be happy to assist Joe to get him acclimated and introduced to the right people.

### PDGA By-Laws Amendment - West

Dave West requested that the board make a plan of action for announcing and passing the proposed change to the PDGA by-laws, which would disqualify paid employees and paid consultants from running for and holding a PDGA board position. Our attorney has written the new by-law language and the language has been reviewed and approved by the board. Graham and Menickelli were in agreement that we should not rush something like this through without allowing the membership adequate time to review it and provide feedback to the board prior to voting. Dave West was tasked with writing an article/announcement for the PDGA website. Once published, we will allow 2 weeks for member feedback before the board considers voting on the proposed amendment.
