Notes: The earliest PDGA elections were held at different times during the year.
 From the late 1980s-2004 BODs were elected in year end elections for 2 years periods beginning February 1.
 The election was moved forward in 2005/06. Balloting now closes at 12:01 AM on August 1, with 2 year terms of office commencing September 1.
 Beginning in 2005, the 2 year term of office will commence September 1.
 Beginning in 2009, the elections were shortened to one month (July)
 Beginning in 2011, Board positions changed to 3-year terms (3) with transition to take place during next two years. BOD can now appoint 2 additional members

Publicity Director originally termed Director #1, then Elections Director (to 1993)
 Oversight Director originally termed Director #2
 Commissioner, Regional Director, Financial Director and Publicity Director elected every 2nd year as follows: ... 2000, 2002, 2004, Sep 2005, etc.
 Competition Director, Communications Director, Oversight Director elected every 2nd year as follows; ... 2001, 2003, 2005, Sep 2006, etc.
